I, the undersigned, understand the nature of the charges against me.  
I understand that I have a right to be represented by an attorney at all stages of the proceedings.

- I hereby give up the right to be represented by an attorney;
- My attorney is present and I have discussed the charges and possible defenses with my attorney;

**I hereby give up the following rights:**

1. The right to a trial and specifically the right to a trial by court.

3. The right to confront and cross-examine the witnesses against me.
4. The right against self-incrimination, which means the right not to testify against myself.

My decision to plead guilty or nolo contendere has been made freely and voluntarily without threat or fear to me or anyone closely related to or associated with me. There have been no promises to me of rewards, immunity, probation, or anything else to induce my plea of guilty or nolo contendere, except
